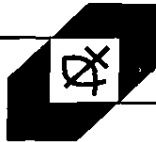


Madam:
