



AMENDMENT TO THE ARTICLES OF INCORPORATION FOR THE CONFEDERATE AIR FORCE Corporations Section

The Confederate Air Force, pursuant to the provisions of Article 4.01-4.05 of the Texas Non-Profit Corporation Act, hereby adopts an Amendment to the Article of Incorporation for the Confederate Air Force.
