



# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GCOP, INC. OF NORTHWEST FLORIDA

Pursuant to the Code of Alabama, Sections 10A-1-3.13, 10A-2-10.03 and 10A-2-10.06, the undersigned corporation, GCOP, INC. OF NORTHWEST FLORIDA, a business corporation organized and existing under the laws of the State of Alabama, hereby submits the following:

- 1. The name of the corporation is GCOP, Inc. of Northwest Florida
- 2. The type of entity is a business corporation.
- 3. The Articles of Incorporation were filed on December 27, 1988 in the Probate Court of Baldwin County, Alabama and were amended by Amended Articles of Incorporation filed on January 21, 1993 and Articles of Amendment filed on September 12, 1997, each of which were filed in the Probate Court of Baldwin County, Alabama.
  - 4. The Articles of Incorporation shall be amended as follows:

ARTICLE I of the Articles of Incorporation is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

#### "ARTICLE I NAME

The name of the Corporation shall be LMJ Holdings, Inc., and any and all references to GCOP, Inc. of Northwest Florida shall hereafter be deemed to refer to LMJ Holdings, Inc."

The within Articles of Amendment have been approved in the manner required by the Alabama Business and Nonprofit Entity Code and are being filed in the Office of the Judge of Probate of Baldwin County, Alabama, for the purpose of effecting such amendment in accordance with the requirements of Code of Alabama 1975, Section 10A-1-4.02.
