Pursuant to our conversation last week, enclosed please find a completed Application by Foreign Corporation for Withdrawal of Authority to Transact Business or Conduct Affairs in Florida for DGIC (#F97000002687), and a completed Application to File Amendment to Application for Authorization to Transact Business in Florida for IPC (#F97000001288). AMENDED AND RESTATED CHARTER
OF

INDEPENDENT PROPERTY AND CASUALTY INSURANCE COMPANY

Pursuant to the provisions of Section 48-20-107 of the Tennessee Business Corporation Act, the undersigned corporation hereby amends and restates its Charter to supersede the original Charter and any and all prior amendments thereto and restatements thereof as follows:

- I. The name of the corporation is Independent Property and Casualty Insurance Company.
- II. The text of the Amended and Restated Charter is as follows:
- 1. Name. The name of the corporation is Direct General Insurance Company.
- 2. <u>Capitalization</u>. The authorized amount of capital stock of the corporation shall be ten million (10,000,000) shares of common stock having a par value of ten dollars (\$10.00) per share ("Common Stock"). Each share of Common Stock shall be entitled to one vote for all matters that may properly come before the shareholders. No holder of any Common Stock of the corporation, now or hereafter authorized, shall have any preemptive right, as such holder, to purchase, subscribe for, or otherwise acquire any shares of stock of the corporation, or any securities or obligations convertible into or exchangeable for, or any right, warrant, or option to purchase, any shares of any class of capital stock which the corporation may at any time hereafter issue or sell, whether now or hereafter authorized.
- 3. Registered Office and Agent. The address of the registered office of the corporation is 1281 Murfreesboro Road, Nashville, Tennessee 37217, located in Davidson County Tennessee. The name of the registered agent is Jacqueline C. Adair.
- 4. <u>Incorporators.</u> The names of the incorporators when the corporation was redomesticated to the State of Tennessee were James S. D'Agostino, Jr., Joe Kelley, and Marcus B. Bergh, Jr. The address for each of the incorporators was American General Center, Nashville, Tennessee, 37250.
- 5. Principal Office. The address of the principal office of the corporation is 1281 Murfreesboro Road, Nashville, Tennessee 37217. The corporation may establish such branch offices and agencies elsewhere in the State of Tennessee and in any other states of the United States and in any foreign country where the corporation may obtain the lawful authorization to do so.
  - 6. <u>Duration</u>. The time for which the corporation shall exist is perpetual.
  - 7. Profit Status. The corporation is for profit

- 8. Purpose and Powers. The corporation shall engage in the business of a multiple line insurance company, writing and issuing casualty, property, surety, vehicle, and other permitted insurance policies as defined under Title 56 of the Tennessee Code Annotated, as amended from time to time, in the State of Tennessee and elsewhere, where authorized, and may engage in any other lawful business that is not legally inconsistent with the foregoing. The corporation shall have the power to:
- (a) appoint licensed agents in the State of Tennessee and elsewhere, where authorized, and to write and issue policies of insurance directly to insureds;
- (b) solicit the issuance of policies of insurance through licensed insurance agents, or directly to insureds, or both;
- (c) enter into any reinsurance treaty or contract as the ceding or assuming company;
- (d) have and exercise all of the rights and powers of authorized insurance companies in the State of Tennessee and elsewhere, where authorized; and
- (e) have and exercise all of the rights and powers of corporations under the Tennessee Business Corporation Act, where not inconsistent with the Tennessee Insurance Statutes.
- State of Tennessee, no present or future director of the corporation (or his or her estate, heirs, and personal representatives) shall be liable to the corporation or its shareholders for monetary damages for breach of fiduciary duty as a director of the corporation. Any liability of a director (or his or her estate, heirs and personal representatives) shall be further eliminated or limited to the fullest extent allowed by the laws of the State of Tennessee, as may hereafter be adopted or amended. Nothing in this charter shall exempt an officer or director from any provision of Title 56, Tennessee Code Annotated as it may be amended, supplemented or superseded.
- 10. <u>Indemnification of Directors and Officers</u>. With respect to claims or liabilities arising out of service as a director or officer of the corporation, the corporation shall indemnify and advance expenses to each present and future director or officer (and his or her estate, heirs and personal representatives) to the fullest extent allowed by the laws of the State of Tennessee, both as now in effect and as hereafter adopted or amended.
- III. The restatement as set forth above contains amendments to the Charter of the corporation that require shareholder approval.

IV. The Amended and Restated Charter as set forth above was duly adopted by the Board of Directors and the sole shareholder of the corporation as of March 14, 1997.

V. This certificate, and the Amended and Restated Charter as set forth above, shall become effective when approved by the Tennessee Commissioner of Insurance and filed with the Secretary of State of the State of Tennessee.

IN WITNESS WHEREOF the corporation has caused its duly authorized officer to execute on its behalf this certificate and Amended and Restated Charter this 17th day of March 1997.
