This letter is written in response to concerns regarding my corporation. In 1997, my Ohio attorney filed our Florida corporation papers, F97000002448. I have only now been informed that I am required to file an Annual Report with the Florida Department of State. I have filled out the Annual Report and attached it. Until now I never received the annual mailings that would have alerted me to having to file an Annual Report. I am now told that I must pay \$900 to reinstate my corporation. This consists of \$150 for 1998 & 1999 as well as a \$600 penalty. I have enclosed a check for \$300 and I ask that the \$600 penalty be waived. It seems harsh to penalize me \$600 because I never filed something I never received, nor did I ever know I was suppose to file. Please advise as to if I need to do anything in addition to this to get my corporation into an active status.
