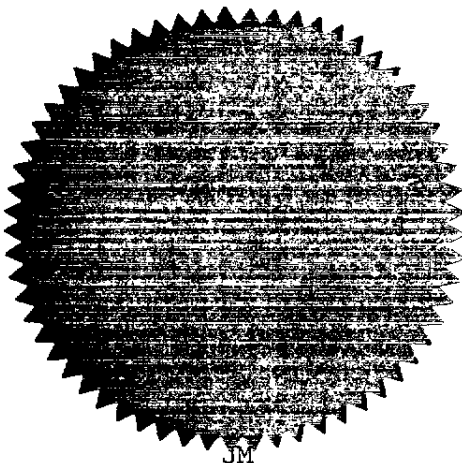
I hereby certify that according to records in this office, Techexport, Incorporated was incorporated under the General Laws of this Commonwealth on January 29, 1971.
