
As of July 18, 2000, the corporation ceased normal business operations and no longer has offices, payroll, assets or business transactions in any state, other than New York State. The Trustee is in the process of liquidating the estate.

The Trustee was not responsible for pre-petition filing requirements and payment of taxes or fees, and therefore cannot represent that either (1) all filing requirements have been satisfied, and (2) all pre-petition taxes have been paid. The Trustee is not authorized to pay pre-petition tax liabilities.

The purpose of this withdrawal is to surrender the company's authority to transact business in the state and cease future filing requirements.


