## LIMITED POWER OF ATTORNEY

KNOW ALL MEN, that each of the corporations listed on Exhibit A, attached hereto and incorporated herein as if set forth verbatim, each duly created, organized and existing under and by virtue of the laws of the State of Delaware, in the United States of America, and each having its principal office at 1400 Smith Street, Houston, Texas 77002-7361, USA (each individually referred to herein as "Company"), do hereby constitute and appoint Robert D.
