Please note on the report that there are changes in the Principal Place of Business and Mailing Address blocks from the data you currently show as on file for Trinity. In particular, the Post Office Box number you currently show is incorrect in that the number of the box is missing one number 8. Your records show it as 88887 (Four 8's), whereas the correct box number should be 888887 (Five 8's).

I believe that due to this error in the mail address, we at Trinity never received the first notice that an Annual Report was due along with the forms for filing same. As a matter of fact, I don't know how the Second Notice reached us with the incorrect address, but somehow it appeared in our mailbox, and we have responded to it. Upon examining the packet, I called and discussed the problem with Mr. Sammy Caldwell on Monday, July 6th, at 1:45 PM.
