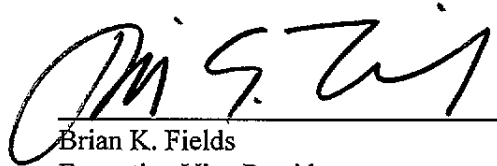

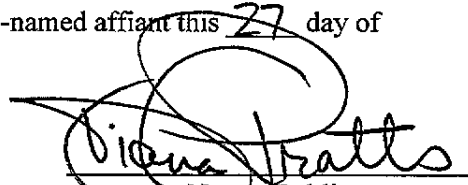
# AFFIDAVIT

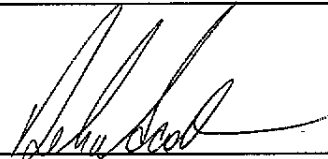
