CERTIFICATE OF AMENDMENT AND RESTATEMENT

Stock Corporation

1. Name of the Corporation:

The name of the Corporation is Jon Pickard Architects, Inc.

2. Amendment and Restatement:

The Certificate of Incorporation is amended and restated.

3. Text of Restated Certificate of Incorporation and of Each Amendment/Restatement:

The Text of the Amended and Restated Certificate of Incorporation is attached hereto as Exhibit A. Without limiting the foregoing, specific amendments to the text are as follows:

- A. Section 1 is amended to change the name of the Corporation from Jon Pickard Architects, Inc. to Pickard Chilton Architects, Inc.
- B. Section 2 is amended to delete reference to one class of shares and to specify that the shares authorized are common stock with unlimited voting rights.
- C. The former Section 3, containing reference to C.G.S. 33-665(b), is deleted in its entirety, the relevant information being now contained in Section 2, as amended. The new Section 3 sets forth the registered office of the corporation, the registered agent at that address and the residence address of the registered agent.
- D. The former Section 4, containing the appointment of the former registered agent is deleted in its entirety and replaced by a new Section 4 as set forth in <u>Exhibit A</u> hereto. limiting personal liability of the directors and shareholders.

4. Vote Information:

The resolution approving amendment and restatement of the Certificate of Incorporation was approved by the shareholders on April 30, 1999, by the affirmative vote of all of the Directors and of the owners of 1000 shares of capital stock, such shares constituting 100% of the capital stock outstanding and 100% of the shares entitled to vote on such resolution. The affirmative vote of 1000 shares of capital stock was sufficient for approval of the amendment and restatement.
