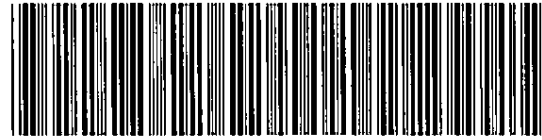



OF

Pursuant to Section 490.1006 of the Iowa Business Corporation Act, Deco Tool Supply Co. adopts the following amendment to its Articles of Incorporation, filed April 17, 1946.

1. The name of the corporation is Deco Tool Supply Co.
2. The following amendment has been adopted:

Article 1 shall be deleted in its entirety and the following inserted in its place:
