Number: W97000022118).
- 2. The Company is a Delaware corporation with its principal offices in Chicago, Illinois, and is registered with the United States Securities and Exchange Commission and the Florida Department of Banking and Finance, Division of Securities and Investor Protection, as a securities broker-dealer. First Chicago solicits and receives orders for securities transactions by mail, telephone, and other means of interstate commerce from persons located in Florida; however, all such orders are accepted and processed in Illinois.
