"Dear Mr. Blackburn,

I am writing you about your certificate of authorization application for Blackburn Architects P.C. As noted on the application instructions,

Rule 61G1-12.001, Florida Administrative Code, states in part that an architect, corporation, partnership, or business entity holding a certificate of authorization shall not advertise goods or services in a manner which is fraudulent, false, deceptive, or misleading in form or content. If the business entity name contains the word "architects" (plural) then the business entity must employ more than one licensed architect.

Please provide the name and license number of an additional licensed architect that is employed with your business. Since you are a foreign corporation, the additional architects can be licensed in any state. If you do not employ another licensed architect, you can register the business name with architect (singular) or architecture.


