- 1. I am the age of legal majority and can truthfully and competently testify to the matters contained herein based on my personal knowledge.
- 2. I am the Vice President-Finance and Treasurer of Axia Incorporated.
- 3. On October 21, 1997, Axia filed an Application by Foreign Corporation for Authorization to Transact Business in Florida ("Application").
- 4. A true, genuine and accurate copy of Axia's Application is attached hereto and marked Exhibit A.
- 5. Axia's principal place of business is Lombard, Illinois.
- 6. Axia's Florida business activities are limited to the ownership of rental construction tools and the presence of resident employees. Axia conducts its Florida business activities through various divisions.
- 7. Axia has had resident employees in Florida since 1992. The activities of Axia's resident employees in Florida are limited to soliciting or obtaining orders. Any orders solicited or obtained by Axia employees are sent outside Florida for acceptance or rejection.

- 8. The division of Axia that owns the rental construction tools in Florida is different than the division that employs the resident employees.
- 9. The division of Axia that owns the rental construction tools conducts no business activities in Florida other than ownership of the rental construction tools. The tools are leased to a subsidiary corporation that is qualified in the state of Florida and numerous other states. It was our belief that the mere ownership of the tools in this arrangement would not require qualification on the part of Axia. It was our belief that the more significant activities of our subsidiary could be considered "doing business" and, therefore, the subsidiary corporation was qualified in Florida.
- 10. Fla. Stat. \$607.1501(2) provides, among other things, that the following activities do not constitute "transacting business" in Florida for purposes of obtaining a certificate of authority from the Department of State: 1) soliciting or obtaining orders, whether by mail or through employees, agents, or otherwise, if the orders require acceptance outside this state before they become contracts; and 2) owning, without more, real or personal property.
- 11. Because Axia's Florida business activities are limited to the ownership of rental construction tools and the presence of resident employees whose duties are limited to the solicitation of orders that must be accepted or rejected outside Florida, in my opinion, Axia is not "transacting business," as that term is used in Fla. Sec. §607.1501 in the state of Florida.
- 12. The rental construction tools referred to above require periodic repair and cleaning and are shipped to centers located outside Florida for repair and cleaning purposes.
- 13. Axia owns rental construction tools and employs resident sales persons in Florida and other states throughout the country.
- 14. Axia files corporate income tax returns in the states of Illinois and Florida, among others, and apportions its income among those states where it conducts its interstate business.
- 15. Under Fla. Sec. §607.1501(2)(i), transacting business in interstate commerce is not considered "transacting business" in Florida for purposes of obtaining a certificate of authority from the Department of State.

- Axia transacts business in interstate commerce and, in my opinion, is therefore not required to obtain a certificate of authority from the Department of State.
- Nonetheless, Axia seeks to obtain a certificate of authority from the Department of State in order to preserve its right to file suit as a plaintiff in a Florida court of law.
- Axia first filed a Florida corporate income tax return for the year ending December 31, 1984.
- Axia began filing Florida sales and use tax returns in 1992 after its first resident employee moved to Florida.
- Despite the fact that Axia has been filing Florida corporate income tax returns since 1984 and Florida sales and use tax returns since 1992, the Department of State failed to notify Axia that it did not have a certificate of authority and males failed, prior to October 1997, to request that Axia obtain a certificate of authority.
