Dear Ms. Lott:

I am in receipt of your November 7, 1997 letter to me at CARE (Letter Number: 397A00054030), in which you determined that CARE must pay penalties in the amount of \$3,565.00 for having conducted business in Florida since April 1, 1994 without having obtained the appropriate authority to conduct business under a Certificate of Authority.

As you will note, CARE was contacted by the Florida Division of Corporations on October 2, 1997 primarily because the Florida Department of Revenue records indicated that CARE was obligated to file Florida corporate income tax returns with your State. Those records are indeed correct and CARE has filed income tax returns for the past years under the name of CARE Systems Corporation.

However, CARE has not conducted business in Florida in any capacity until 1997. It is for that reason that CARE made application to your Department to obtain the appropriate Certificate of Authority for the year 1997.

In the years prior to 1997, CARE filed Florida income tax statements because of CARE's ownership and control of two (2) wholly-owned subsidiary corporations conducting business in Florida: Integrated HealthCARE Delivery Services Corporation and CARE Admin Services, Inc. CARE filed a consolidated tax return. Such activity appears to fall within the scope of Florida Statutes §607.1501 (2)(k).

In 1997, CARE is conducting business in Florida, in its own capacity, through its licensing of its proprietary workers' compensation claims management software to a large Florida corporation. This is the reason that CARE filed application for a Certificate of Authority in 1997.
