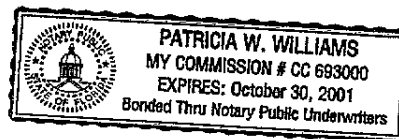

ARTICLES OF AMENDMENT

Crocker Realty Inc, a Maryland corporation (the "Corporation"), having its principal office at The Corporation Trust Incorporated, 300 East Lombard St, Baltimore, MD 21202, hereby certifies to the State Department of Assessments and Taxation of Maryland (the "Department") that:

FIRST: The Corporation desires to amend its charter as currently in effect, consisting of Articles of Incorporation filed on October 24, 1997 and Amended and Restated Articles of Incorporation filed November 12, 1997 (the "Articles of Incorporation" or "Charter"), with the Department, as hereinafter provided. The provisions set forth in these Articles of Amendment of Articles of Incorporation amend the provisions of the Charter of the Corporation as currently in effect. The Articles of Incorporation of the Corporation are hereby amended by striking out Article II, and inserting in lieu thereof the following:

The name of the corporation is:

SECOND: At a meeting on December 12, 1997, pursuant to Section 2-408 of the Maryland General Corporation Law, the board of directors of the Corporation duly adopted a resolution in which was set forth the foregoing amendment to the Charter, declaring that the said amendment of the Charter as proposed was advisable and directing that it be submitted for action thereon by the shareholders of the Corporation.

THIRD: That the said amendment has been approved and authorized by the shareholders of the Corporation at a special meeting on December 12, 1997 as provided by law and the Charter in accordance with the provisions of Section 2-604 of the Maryland General Corporation Law.
