Enclosed please find the Uniform Business Report (UBR). I would like to confirm with you the following per our conversation on Wednesday, October 08, 2003.

- 1) Infotext Sales Corporation (Infotext) filed a complete 1999 UBR.
- 2) Infotext failed to file a 2000 UBR and thus their certificate of authority was revoked on 9/22/00.
- 3) Infotext never received any correspondence from your office regarding failure to file the return or the revocation of the certificate until September 19, 2003.
- 4) Per our discussion, Infotext is filing one UBR for the years 2000-2003 and including a payment of \$600 (\$150 x 4 years) in full settlement of those years and for reinstatement of their certificate of authority.
- 5) We understand that all other reinstatement fees have been waived.
