Pursuant to the provisions of Chapters 607 and 621, Florida Statutes, JOHN C. BARNES, M.D., PEDIATRIC RADIOLOGY ASSOCIATES, P.A. (the "Corporation") amends its Articles of Incorporation as follows:

1. Name. The name of the Corporation is: JOHN C. BARNES, M.D., PEDIATRIC RADIOLOGY ASSOCIATES, P.A.
2. Effect Upon Shares. This Amendment does not provide for an exchange, reclassification, or cancellation of issued shares in the Corporation.
3. Approval. This Amendment was unanimously approved by the shareholders of the Corporation on even date herewith.
4. Adoption. This Amendment was adopted by the Board of Directors of the Corporation on even date herewith.
5. Amendment. Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following provision is substituted therefor:

6. Effective Date. This Amendment shall become effective upon filing with the Florida Department of State.




