AMENDMENT TO ARTICLES OF INCORPORATION OF NEIL A. AHNER, INC.

The undersigned, being the sole Shareholder and the sole Director, for the purpose of amending the Articles of Incorporation of Neil A. Ahner, Inc. pursuant to the Florida Business Corporation Act, Florida Statutes §§607.1001, et seq., does hereby adopt this Amendment to the Articles of Incorporation previously approved by the sole Shareholder and the sole Director of the Corporation:

ARTICLE I

The name of the Corporation is changed to Neil A. Ahner, M.D., Inc.

Except to the extent that any of the provisions of these Articles of Amendment are expressly in conflict with the provisions of the Corporation's original Articles of Incorporation or any previous amendments to the Corporation's original Articles of Incorporation, the Corporation's original Articles of Incorporation and any amendments to the Corporation's original Articles of Incorporation shall remain in full force and effect.

The sole Shareholder and the sole Director previously approved and adopted these Articles of Amendment. The number of votes cast for approval and adoption of these Articles of Amendment was sufficient for approval.
