This letter is in response to your letter No. 997A00054642 on November 13, 1997 to Jack Lynch & Associates, Inc.

There was no erroneous information on our submitted application. Please refer to your second paragraph, first sentence. The sixth line of our application gave 1983 as the "(date first transacted business in Florida)", not as stated in your letter, "the corporation has transacted business in the State of Florida since January 1, 1983." Our firm provided engineering services for projects built in Florida, only between 1983 and 1986. No business was transacted in Florida, from 1986 until the present time, that required a Certificate of Authorization.


We had anticipated possibly starting new projects in Florida that would require our firm to again transact business in Georgia and Florida for these projects. We asked for and received a copy of the Florida Business Corporation Act Booklet. It was our interpretation of this booklet that a Certificate of Authorization would probably be required for the new projects. It was also our hope that Florida would give us the consideration stated in the first part of Section 607.0505 (1)(b). (Enclosed) The July 25, 1997 letter you referenced, stated that our filing would be considered abandoned within 60 days if we did not respond.
