Joseph J. Marion, being first duly sworn upon oath, deposes and states as follows:

- I am the President of the North-American Association of Telecommunication Dealers, Inc., a
 Minnesota corporation ("NATD"). I am competent to testify to the matters stated herein
 which are based upon my own personal knowledge.
- 2) The Application by Foreign Not for Profit Corporation for Authorization to Conduct its Affairs in Florida, filed by NATD with the Secretary of State of Florida on or about November 24, 1997, which stated that NATD began transacting business in Florida on August 31, 1996 was erroneous. This date was erroneously submitted taking into consideration the move of Marion Associates, Inc. to Florida.
- 3) Marion Associates, Inc. is a management company which was retained by NATD to management affairs. I am also President of Marion Associates, Inc. Marion Associates, Inc. was registered to transact business in Florida as of September 17, 1996.


