#### **EXHIBIT A**

The Corporation is incorporated under the Pennsylvania Nonprofit Corporation Law of 1988, 15 Pa. C.S.A. § 5101 et seq., (the "Act") for the following purpose or purposes:

- A. The Corporation is organized and shall be operated exclusively for the charitable, scientific, educational and religious purposes of supporting and strengthening the health care ministries of the Sponsoring Organizations (comprised of certain Regional Communities and Religious Congregations) which operate and are controlled in conformity with the ethical and moral teachings of the Roman Catholic Church, and promoting efficient governance and management, cooperative planning and the sharing of resources among such health care ministries. Specifically, the Corporation is organized and shall be operated exclusively for the benefit of the aforesaid health care ministries, as well as those Constituent Corporations of the Corporation that are described in Section 501(c)(3), and Section 509(a)(1), Section 509(a)(2) or Section 509(a)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax law (hereinafter the "Code").
- B. The Corporation shall not be operated for the pecuniary gain or profit, incidental or otherwise, of any private individual. No part of the net earnings of the Corporation shall inure to the benefit of, or to be distributable to, its Directors, Officers or other private individuals, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes set forth herein. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

  Notwithstanding any other provisions of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code; or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.
