### EXCERPT FROM BHAKTI YOGA SOCIETY, INC. CERTIFICATE OF INCORPORATION

Two: This corporation is a not-for-profit religious corporation organzied under Section 402 of the New York Not For Profit Law. This corporation, as defined in Section 102(a)(5) of the Not-for-Profit Corporation Law, is organized exclusively for a purpose or purposes, not for a pecuniary profit or financial gain, for which a corporation may be formed under this chapter, and no part of the assets, income or profit of which is distributable to, or enures to the benefit of, it members, directors or officers except to the extent permitted under this statute.

The corporation is a Type B corporation as defined in Section 201 (b) of the Notfor-Profit Corporation Law, and the specific purposes for which this corporation is organized are:

- (a) To systematically propagate spiritual knowledge to society at large and to educate all peoples in the techniques of spiritual life in order to check the imbalance of values in life and to achieve real unity and peace in the world. These principles are derived from authorized Vedic literature as translated and presented by His Divine Grace A. C. Bhaktivedanta Swami Prabhupada, founder and preceptor of the International Society for Krishna Consciousness.
- (b) To bring the members of the Association, as well as the general public, together with each other and nearer to Vedic knowledge and self-realization, the prime goal of life, and thus to develop the idea, within the members, and humanity at large, that each soul is part and parcel of the Supreme Personality of Godhead (Krishna).
- (c) To distribute spiritually sanctified foodstuff (prasadam or "mercy of the Lord") to society at large as a method of both spiritual and material upliftment. Materially this prasadam distribution is meant to alleviate hunger, and spiritually it is meant to spiritually bless those who partake of it.
- (d) With a view towards achieving the aforementioned purposes, to publish newsletters and pamphlets, to receive, administer, and distribute funds, and do all other things necessary and proper.
