

Enclosed is check for fees and penalties with respect to authorization to do business in Florida. We ask your consideration in reducing this penalty as circumstances affecting our business since 1995 were very much out of control. We are a small privately owned business started in Arkansas as a single state operation in 1994, and whose first operations in Florida began unanticipated at the end of 1995 as a very short time assignment. The business our company performed in Florida was expected to be on a temporary basis for a very short time, at the request of a new Georgia-based customer who had been receiving aircraft maintenance in several facilities around the country and had not planned extended services in Florida. The primary customer for our Company who had been supporting our business in Arkansas had announced cancellation of our contract (which had been 95% of our business) and it looked like we would be out of business by the end of the year with a sizeable loss.

As a small company, I was the entire accounting, legal department. I was out of the office for several months between October 1995 and February 1996 for maternity leave and complications which caused a tremendous back log in most of the accounting and filings. We hired several contract accountants and even a CPA to maintain the records and reconcile our bank accounts only to have an even worse mess than had we done nothing! To add to the backlog, we were forced to suddenly move our offices to Dallas when our Arkansas customer canceled our contract and asked us to vacate our offices at their facility. It took until only recently as we are settled in Texas, to get records sufficiently caught up to determine any deficiencies that might exist.

We ask your consideration of our circumstances as well as a small company who has tried to meet whatever obligations for taxes and fees that we can possibly figure and who have relied on outside legal advice which apparantly was deficient. We have always made every effort humanly possible to meet our obligations and were not aware of this requirement until receiving your letter in 1997. We had been filing quarterly wage reports with the State since 1995 and assumed this was satisfying any requirements there might be - or someone would have informed us sooner. Again, our sincere apologies for any oversight.
