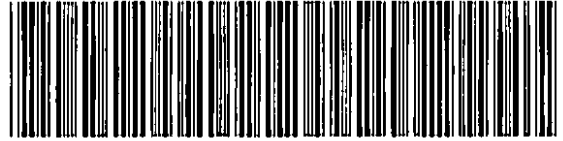



TO THE CHARTER OF
