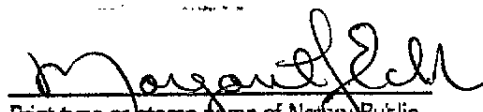
Thank you for your letter of March 30, 1998.

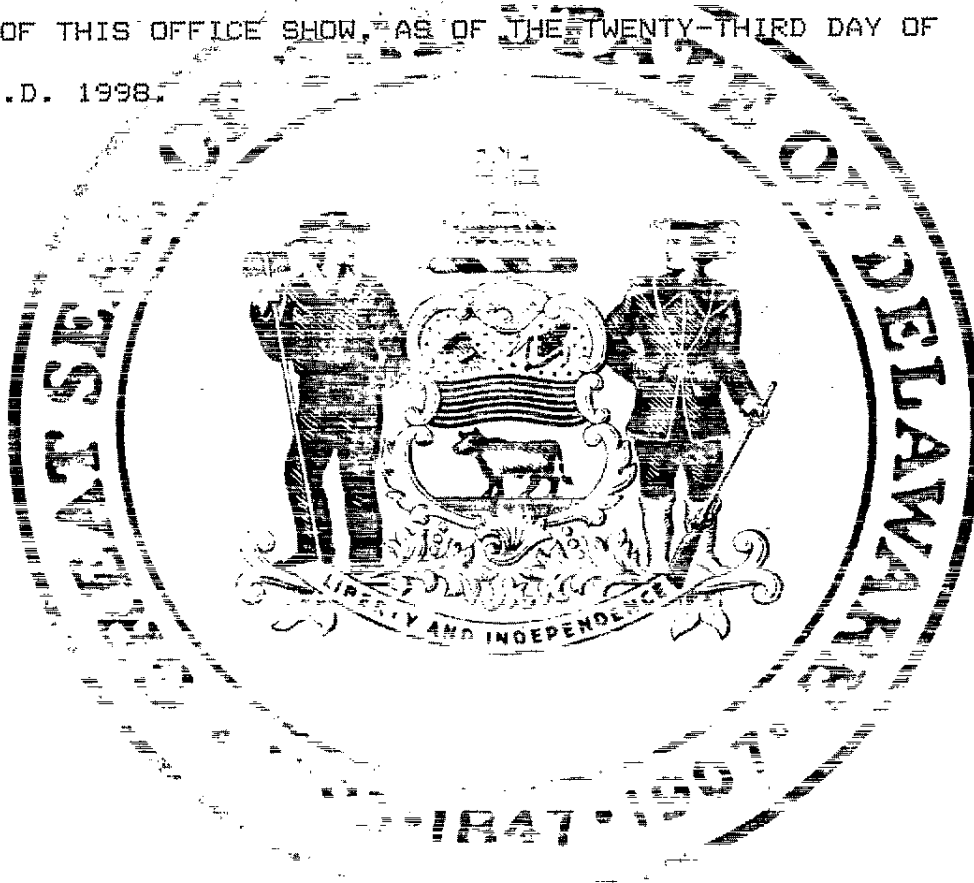
