#### THE NATIONAL CONFERENCE FOR COMMUNITY AND JUSTICE, INC. AMENDED PURPOSES

To receive and maintain a fund or funds of real and/or personal property and apply the whole or any part of the income and/or principal thereof exclusively for educational or charitable purposes by such agencies and means as shall from time to time be found appropriate therefor, including in such purposes the promotion of justice, amity, peace, understanding, respect and cooperation among persons of all races, religions, cultures and ethnic backgrounds, and to analyze, ameliorate and strive to eliminate the inter-group bias, bigotry, prejudices, and racism which disfigure and distort religious, business, social, community and political relations, with a view to the establishment of a social order in which the religious, moral and ethical ideals of mutual respect and justice shall become the standards of human relationships.

The corporation is not formed for pecuniary profit and shall not make or declare dividends nor shall any part of its net earnings enure to the benefit of any private individual. The property of this Not-For-Profit corporation is irrevocably dedicated to charitable and/or religious purposes and on dissolution none of its assets shall enure to any individual but shall be distributed to a corporation, fund or foundation whose property is dedicated to exempt purposes and which has established its tax exemption status under appropriate provisions of the Internal Revenue Code of 1986, as amended.

The corporation shall not engage in any activity which will bring it within the purview of paragraph (b) or (c) or paragraphs (e) through (v) of Section 404 of the Not-for-Profit Corporation Law of the State of New York nor shall it be or conduct or operate a university, college, academy, library, museum or other institution or association for the promotion of science, literature, art, history or other department of knowledge.

Subject to the foregoing and to any other restrictions which may apply pursuant to the Not-For-Profit Corporation Law, the corporation shall have all powers permitted by the Not-For-Profit Corporation Law.
