ARTICLES OF INCORPORATION
OF
CHRISTIAN MINISTRIES INTERNATIONAL

The undersigned, for the purposes of forming a corporation under the Non-Profit Corporation Law of the State of Louisiana, hereby makes, signs and acknowledges these Articles of Incorporation, stating as follows:

ARTICLE I.

NAME

The name of the corporation is **Christian Ministries International**.

ARTICLE II.

NON-PROFIT CORPORATION

Christian Ministries International is a non-profit corporation the duration of which shall be perpetual.

ARTICLE III.

PURPOSES AND POWERS

This corporation is formed for the purpose of ministering the Gospel of Jesus Christ and doing missionary work in His Name. Recognizing that the corporation must be financially sound and should have due regard for public acceptance and critical judgment, Christian Ministries International must serve to achieve the purposes and objectives set forth above, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code. In furtherance of such purposes, this corporation shall have all powers granted to non-profit corporations under the laws of the State of Louisiana, provided that the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by any organization exempt under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter exist, or by any organization contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter exist.

The corporation shall operate exclusively for the purposes above stated, and no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any private

member, trustee, officer or other private person, provided, however, that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth hereinabove. No substantial part of the activities of the corporation shall include carrying on propaganda, or otherwise attempting to influence legislation except as permitted by law, and the corporation shall not intervene in any political campaign on behalf of any candidate.

ARTICLE IV.

NON-STOCK ORGANIZATION

This corporation shall be organized on a non-stock basis, shall issue no capital stock, and shall have no shareholders.
