WILLIAM I. STOPPERAN, after being first duly sworn on oath, deposes and states as follows:

- 1. He is the President of Western Pathology Consultants, Inc., a Nebraska Corporation, and has knowledge of the facts stated herein.
- 2. Western Pathology Consultants, Inc. has filed with the Florida Department of State an "Application by Foreign Corporation for Authorization to Transact Business in Florida" (the "Application").
