**APPLICATION BY FOREIGN CORPORATION
FOR WITHDRAWAL OF AUTHORITY
TO TRANSACT BUSINESS OR CONDUCT AFFAIRS IN FLORIDA**

Pursuant to the provisions of Section 607.1520 of the Florida Business Corporation Act, Orient Lines Ltd., a Bermuda corporation authorized to transact business in the State of Florida under the corporate name Orient Lines Ltd., a Bermuda Corporation (the "Corporation") submits the following statements for the purpose of withdrawing its authority to transact business:

1. The Corporation is no longer transacting business or conducting affairs within the State of Florida, pursuant to its merger with and into Norwegian Cruise Line Limited, a Bermuda Corporation effective December 4, 1999, and hereby voluntarily surrenders its authority to transact business or conduct affairs in Florida.


2. The Corporation revokes the authority of its registered agent in Florida to accept service on its behalf and appoints the Department of State as its agent for service of process based on a cause of action arising during the time it was authorized to transact business or conduct affairs in Florida.
