Dear Sirs:

Last July of 1997 I took over doing the bookkeeping for Michael Biamonte and Associates. We are a New York Corporation. Before I took over the bookkeeping was done by a firm in California called Wiseman and Burke from Jan 96 to June 97. In 1996 Dr. Biamonte moved to Florida from New York with him family and started doing consultations from his home phone to his patients in New York. He works part of each month in New York and part from him home in Florida so he could be with his family.

When I took over the bookkeeping I did not know the company was not registered as a foreign corporation doing business in Florida. I am sure that Wiseman and Burke was not aware that he needed to register as they are a reputable firm but possibly not aware of Florida law. As May 1st approached to file the Annual Corporate Returns I realized that I did not receive the form from the State of Florida. I called Dr. Biamonte's accountant, Marlin Anderson and he guided me on how to get the application that I am now sending in to you.

Dr. Biamonte was not aware that this other accounting firm did not have all the company's legal requirements in until I informed him recently. I called the State to find out what the penalties are for not filing for two years and was told it was \$1000.00 for each year plus \$150. registration for two years plus the \$70.00 registration fee. This is a very stiff penalty which I am certain you are aware of already. I am sure it was meant for people who try to get around this law for the purpose of being fraudulent and not paying their fair share according to the laws of the land. But this is not the case with us. That I am applying for two years back of my own accord should show you that this is true.

I would respectfully request that under the circumstances that the penalties be waived in full or in part. I would greatly appreciate your consideration in this matter.
