CRC-Evans Weighting Systems Inc. (FEI #73-1537870; charter # F98000004306) has received notice that our registration in Florida has been revoked due to our failure to complete a Uniform Business Report for the year 2003. Our registration was revoked in 2004.

We have done business in Florida and have filed franchise and income taxes since then, unaware that our registration had been revoked.

We contacted our agent, CT Corporation, and found out through them that the state of Florida had as our principle office address the address of our (at that time) parent company, Louisville Gas and Electric (LG&E), in Louisville, KY. LG&E sold us in 2003.

We believe your request for our annual report and renewal information for 2003 was sent to LG&E and was not forwarded to us because we were no longer associated with them. Hence, our registration expired, unbeknownst to us.

We therefore request the reinstatement fee imposed on us be waived.
