#### RESTATED CERTIFICATE OF INCORPORATION

OF

#### AMERICAN RED MAGEN DAVID FOR ISRAEL

Under Section 805 of the Not-for-Profit Corporation Law

FIRST: The name of the corporation is American Red Magen David for Israel. The name under which the corporation was formed is: American Red Magen David For Palestine, Inc.

SECOND: The certificate of incorporation of the corporation was filed by the Department of State on October 4, 1940.

THIRD: The corporation was formed under the Membership Corporation Law.

FOURTH: The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-for-Profit Corporation Law.

FIFTH: The corporation is a Type B corporation under Section 201 of the Not-for-Profit Corporation Law.

SIXTH: The amendments of the certificate of incorporation of the corporation effected by this restated certificate is to change the name of the corporation and to designate the address to which the Secretary of State shall mail a copy of any process accepted on behalf of the corporation.

SEVENTH: To accomplish the foregoing amendment, Articles 1 of the certificate of incorporation of the corporation, relating to name of the corporation, and Article 6 of the certificate of incorporation of the corporation, relating to the address to which the Secretary of State shall mail a copy of any process accepted on behalf of the corporation are hereby amended to read as set forth in the same numbered article(s) of the certificate of incorporation of the corporation as hereinafter restated.

EIGHTH: The restatement of the certificate of incorporation of the corporation herein provided for was authorized at a meeting of the Board of Directors at which a quorum was present, by the vote of a majority of the entire Board of Directors, the corporation having no members entitled to vote on said restatement.

NINTII: The text of the certificate of incorporation of the corporation is hereby restated as amended or changed herein to read as follows:

"FIRST: The name of the corporation shall be American Friends of Magen David Adom.

SECOND: The corporation is a Type B corporation under Section 201 of the Not-for-Profit Corporation Law.

THIRD: Its purposes are:

To solicit, collect and otherwise raise money for the purchase of medical and surgical supplies and equipment for the benefit of the people of Israel, regardless of race, creed or color, and to expend, contribute, disburse and otherwise handle and dispose of such money for such purposes and to administer and distribute such supplies and equipment either directly or by contribution to or through individuals or other agencies, organizations or institutions, organized for the same or similar purposes.

To solicit, collect and otherwise raise money for the establishment, maintenance of hospitals, dispensaries, clinics, first aid stations, ambulance units and air-raid shelters in Israel for the benefit for the people of Israel, regardless of race, color or creed, and to expend, contribute, disburse and otherwise handle and dispose of such money for such purpose, and to administer and distribute such monies either directly or by contribution to or through individuals or other agencies, organizations or institutions organized for the same or similar purposes.

To establish, supervise and maintain in Israel dispensaries, first aid stations, ambulance units and air-raid shelters for the benefit of the people of Israel, regardless of race, creed or color, either directly or by contribution to or through individuals or other agencies, organizations or institutions organized for the same or similar purposes.

By itself and in cooperation with other individuals or organizations to work for the alleviation of the privations, suffering and needs of the people of Israel, and to bring to the attention of the people of the United States the existence of such privations, suffering and needs, and to collect, solicit, and otherwise raise money for the relief and rehabilitation in said Israel of its people, and to expend, contribute, disburse and otherwise handle and dispose of such money for such purposes and to administer and distribute such money either directly or by contribution to or through individuals or other agencies, organizations or institutions organized for the same or similar purposes.

To solicit, collect and otherwise raise money for charitable, philanthropic, eleemosynary and benevolent purposes in Israel and to expend, contribute, disburse and otherwise handle and dispose of such money for such purposes and to administer such money and distribute the same either directly or by contributions to or through individuals or other agencies, organizations or institutions organized for the same or similar purposes.



To acquire or receive by gift, grant, bequest, devise or otherwise, real and personal property or every nature and description and wheresoever situated, and to hold, deal and dispose of the same, or the income and proceeds thereof, in such manner and in such form and to such extent as may be necessary to carry out the purposes and objects of the corporation, within the limits allowed by law.

To do any and all of the things herein set forth, and in addition such other acts and things as may be necessary or convenient to attain the purposes of this corporation or any of them to the same extent as natural persons lawfully might or could do in any part of the world.

The foregoing clauses shall be construed both as objects and purposes an it is herein expressly provided that the foregoing enumeration of specific objects and purposes shall not be held to limit or restrict in any manner the powers of the corporation:

FOURTH: The county in which its office is to be located is New York

FIFTH: The number of its directors shall not be less than three or more than twenty-four.

SIXTH: The Secretary of State is designated as agent of the corporation upon whom process against the corporation may be served. The post office address of the corporation within the State of New York to which the Secretary of State shall mail a copy of any process accepted on behalf of the corporation is as follows: 888 Seventh Avenue, Suite 403, New York, New York 10106."
