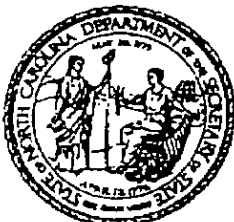

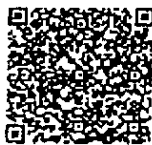

**ARTICLES OF AMENDMENT  
FOR  
CROSS SALES AND ENGINEERING COMPANY**

Pursuant to Section 55-10-06 of the General Statutes of North Carolina, Cross Sales and Engineering Company hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation as follows:

1. The name of the corporation is Cross Sales and Engineering Company (hereinafter the "Company").

2. Article I of the Company's Articles of Incorporation is hereby amended and restated as follows:

" Article I

The name of the corporation is Cross Technologies, Inc."

3. The amendment was approved by shareholder action, and such shareholder approval was obtained as required by Chapter 55 of the North Carolina General Statutes. The Amendment set forth in these Articles of Amendment was approved by the Company's Board of Directors on June 11, 2014 and by its sole shareholder on June 11, 2014.
