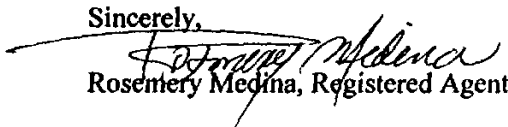
RE: Late filing of the 1999 Corporate Annual Report for International Training Partners, Inc.
