Enclosed is the Corporation Reinstatement form and our fee of \$150, as the annual fees for the above-referenced corporation for 2002.

We are requesting waiver of the penalties for this matter because we did not receive the 2001 Uniform Business Report ("UBR") and we did not expect to get a UBR for this corporation as it merged into WCI Communities, Inc. during 2001. Both WCI Communities, Inc. and Watermark Communities, Inc. are Delaware corporations. The Articles of Merger were filed in Delaware, and not Florida, due to administrative oversight. This error was discovered when we received the notice of dissolution. We are seeking to reinstate this corporation to good standing and request that the penalty for failure to file the 2001 UBR be waived. We will be filing the Articles of Merger in Florida in the next few weeks, after reinstatement is complete. Thank you for considering this matter.
