My name is Belvaly W. Birdzell. I am Vice President of the corporation National Weight Loss Centers of Alabama, Inc. National Weight Loss Centers is in the business of providing weight loss services to individuals throughout the country. We currently have centers in various locations.

National Weight Loss Centers of Alabama, Inc., and specifically the Pensacola center, claims exemption from the requirement of filing an Application by Foreign Corporation for Authorization to Transact Business in Florida for the period November, 1994, to present. This exemption is claimed pursuant to the provision of Florida State 607.1501(2)(i) which said statute provides that "transacting business in interstate commerce does not constitute transacting business within the meaning of Section (1)".

Each of our centers, including the Pensacola center, conducts business in interstate commerced in that we order supplies from various vendors in other states, many of our lab procedures are evaluated and/or sent out to other states for analysis, and our advertising reaches across state lines in many instances.

While we do claim the exemption with regard to the Pensacola center for the period stated, we would request that the Application By Foreign Corporation for Authorization to Transaction Business in Florida filed on or about October 1, 1998, with the Division of Corporations, Florida Department of State, be processed so that the appropriate authorization may be issued. We look forward to our continued association with the State of Florida and anticipate that our Pensacola center shall remain a good corporate citizen for many years to come.
