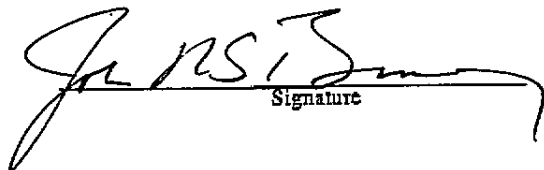

KISTERS, INC., a Kentucky Corporation, amends its Articles of Incorporation, and hereby delivers to the Secretary of State for filing, its Articles of Amendment, pursuant to K.R.S. 271B.10-060, as follows:

- (A.) The name of the Corporation is KISTERS, INC.
- (B.) The Amendment adopted is as follows:
 - 1.) ARTICLE I shall be amended to read as follows:

ARTICLE I

This Corporation shall be named and known as "KISTERS KAYAT, INC."

- (C.) The Amendment does not call for an exchange, reclassification, or cancellation of issued shares.

- (D.) The aforesated Amendment was recommended on October 22, 1998 by the Board of Directors of the Corporation at a special meeting called for that purpose and adopted by the sole Shareholder, Kisters Maschinenbau GmbH on the same date.
