I am responding to your letters dated March 6, 1998 and June 11, 1998 referred to above. A brief history as to what has occurred will help clarify our situation.

United Management, Inc. is incorporated in the State of Ohio and manages several companies which own shopping centers and operate under the trade name of The Don M. Casto Organization. United Management, Inc. also employs all the personnel who work at the various companies under The Don M. Casto Organization. It acts as a "common paymaster" to reduce the number of payroll tax filings with the various the Federal, State and Local taxing authorities.

A new business venture is planned for Florida. The actual shopping center will be owned by Winter Park Town Center, Limited which is registered as a limited partnership in the State of Florida (Document # A 97000001919).



The problem has been that the actual management company of Winter Park Town Center, Limited was to be a new Florida corporation, but employee was hired effective October 17, 1997 without such new corporation being formed. United Management, Inc. paid the employee and related payroll taxes with the expectation of being reimbursed when the new corporation was formed. Additional employees were hired in 1998 and I was informed that United Management, Inc. would be the Florida management company. I therefore asked our legal counsel to prepare the necessary application to register United Management, Inc. as a foreign corporation in Florida. Subsequent to filing the application, I was informed that the new Florida corporation idea was being reconsidered; I then received your March 6, 1998 letter and as of today I still do not have the final decision on what we are going to do. This decision will be made by the end of August, 1998.

Based on the information you provided regarding Florida Statute 607.1501, I believe that United Management, Inc. has not transacted business itself in the State of Florida. United Management, Inc. has incurred payroll costs which is expected to be reimbursed from the proposed new corporation. The October 17,1997 date was used solely because that is when the first employee in Florida was hired.

With the information provided, please advise what our status would be and what should be done next.
