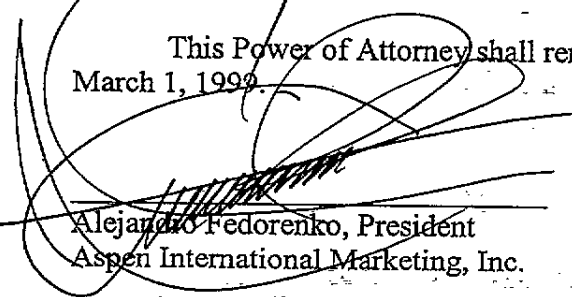
## Power of Attorney

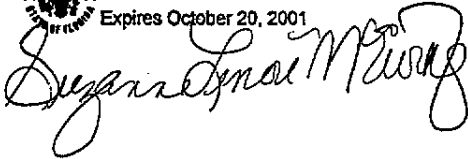
