FIVE: To appoint those agents which he may deem convenient, as well as any other subordinate personnel, and to determine salaries and pay commissions.

<u>SIX:</u> To substitute all or part of the powers conferred upon him by this Power of Attorney, by public or private act.

SEVEN: To perform any ordinary or extraordinary act of administration which, in his opinion, may be convenient for the corporation, including acts of strict domain.

EIGHT: The foregoing powers do not constitute any limitation whatsoever, and the Attorney shall have the power to carry out any act for and on behalf of the corporation.
