
Remsberg Tent Rentals, Inc believes that incorrect information was listed on our Application By Foreign Corporation For Authorization to Transact Business in Florida. The information for line 6 of the application, date first transacting business in Florida, was filed as "Upon Qualification." However, your department listed this date as April 1, 1985, our date of incorporation. We feel that "Upon Qualification" is the correct date.

Remsberg Tent Rentals, Inc. did begin transacting business in Florida in April, 1997 but this did not constitute transacting business as per your statute 607.1501 (2) (j). Our business consists of renting party tents for private, corporate and sporting events. Our business in Florida consisted of an isolated contract for a specific event. We have since completed a few other isolated contracts for completely different events.

In 1999, however, we will be doing substantially more business in Florida and it will be repeat business for prior customers and events. Therefore, we feel that we will no longer qualify under the aforementioned statute and as such are submitting this application.

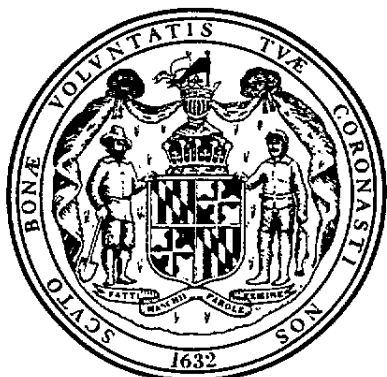
