In today's mail, I received the above referenced report, marked, Second Notice. Please be advised, we never received the Original Notice. I note that this notice had been sent to our old office in New York City, and what ever mail that goes there, usually does not get forwarded any longer, since the forwarding from the post office has long since expired. I do not understand why you would be sending something to an old address, when everything from the State of Florida has been coming to the Aventura address ever since we moved here, in January of 1999. I asked my accountant about this report, and he informed me that the annual fee is \$150, not \$550.

He also mentioned that the report is usually filed in May, which I assume is when the Original was sent. Was the Original sent to our old New York office, because, I never received it, here, at what has been our Florida address since the beginning of 1999. When we applied for Authority to do business in Florida, we listed the Aventura address as our principal place of business.

Please correct your records accordingly.

I am enclosing our company check to cover the \$150 filing fee, plus \$8.75, for the Certificate of Status, as well as an additional \$5.00 for the Campaign Financing Trust Fund.
