Dear Sir or Madam:

Pursuant to my telephone inquiry, we are enclosing the Application for Reinstatement for Relocation Resources International, Inc., together with the Annual Report fee of \$150.00.

I explained why we had not filed the 2000 Annual Report/Uniform Business Report, and was asked to confirm the explanation in writing.

We were surprised to receive a Notice of Administrative Dissolution or Revocation as we had not received the 2000 Annual Report/Uniform Business Report form. Moreover, in September 2000 we had requested a certification of the status of our registration, and on September 14, 2000, the State of Florida issued the enclosed Certificate. The Certificate indicates that the corporation has paid all fees due through December 31, 1999. Not only had we not received the Report, but we assumed from the Certification that no fees were due until December 2000, i.e. one year from the date of last payment.

Based on the fact that we had not received the Report, and because of the misunderstanding resulting from the Certification, issued 8 days before the termination, and referring to a December date, we respectfully request that the Reinstatement fee of \$600 be waived.
