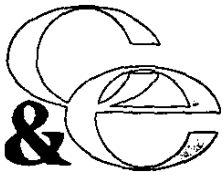

The purpose of this letter is to address three specific issues: (1.) to submit the above referenced Taxpayers Corporation Reinstatement Report for years 2000 through 2003, (2.) a request to accept the enclosed reinstatement fee of \$600.00 in lieu of the prescribed reinstatement fee of \$1,200.00, based on the establishment of reasonable cause for failure to file such reports, and (3.) a request to both fax and mail the requested Certificates of Status for each year to our office.

**Issue One.**

In the past, the management group for the above-referenced Taxpayer, who are based in Europe and not in the United States, had engaged several different U.S. based state tax compliance professionals and organizations to keep the management team aware of and prepare all required forms, reports, etc. related to their various State mandated business tax and franchise filings. With regard to the preparation and filing of the Florida Uniform Business Reports for the years 2000 - 2003, the Taxpayer never received the standard report forms package in their foreign corporate offices nor at their U.S. mailing address. The management team for the Taxpayer, acting within prudent and reasonable business management standards, relied on the outside compliance professionals to inform them of their U.S. state filing responsibilities and to prepare such forms, reports, etc. for their review and execution. Unfortunately, the engaged professionals did not perform as expected.

Based on the above discussion, the Taxpayer is respectfully requesting that the enclosed reinstatement fee of \$600.00 be accepted as full payment for the report years 2000 through 2003.

Issue Two.
