The undersigned, being duly sworn according to law, attests as follows:

I am a partner at the law firm of Gurman, Blask & Freedman Chartered, which is resubmitting an application by CommcoTec Corporation for Foreign Corporation Authority in the state of Florida. The first application was rejected for filing by the State of Florida for three reasons: (1) absence of the Federal Employer Identification Number, (2) the document was not signed by an officer of the Corporation, (3) the incorrect date for commencing business in Florida was stated.

We have provided the Federal Tax Identification Number and the Required signature.

In answer to number three (3), referring to the date CommcoTec expected to commence business in Florida, we stated, in typographical error, that CommcoTec Corporation would commence business on June 1, 1998. The actual date CommcoTec intends to commence business operations in Florida is June 1, 1999. CommcoTec currently does not maintain any place of business nor employees in the State of Florida.
