



Dear General Counsel,

We are writing to appeal the civil penalty of \$3000 which has been assessed against The Dermal Group, Inc. (DGI) for operating in the state of Florida as a foreign corporation without due filings. We thoroughly agree with the Florida Statutes that we have been in violation due to our negligence in filing for qualification and the annual reports.

Please note that DGI is a Virginia corporation in good standing within the state of Virginia and hope to maintain the same standing operating within the state of Florida. We undertook what we believed to be the appropriate filings including:

- 1) Incorporating with the Florida Division of Unemployment Compensation and filing quarterly employer reports.
- 2) Incorporating with the Florida Department of Revenue and reporting monthly sales and use tax.
- 3) Incorporating with the Florida Department of Revenue and reporting annual corporate taxable income and paying the appropriate corporate tax due.
- 4) Incorporating within the Florida county of Broward and filing the annual tangible property tax return.

We hope that you can see from the above that we believed we were in full compliance with <u>all</u> of Florida's Statutes. Unfortunately, we did not file the required annual report with the Department of State. Please understand that it was not our intention to mislead the State of Florida in any manner and fully agree with the annual report fee assessment of \$515.

Please use your judgment in reviewing the penalty assessed and we would be pleased with any abatement that you feel would be appropriate in our particular situation. If you have any questions in relation to this matter, please contact me at 310-352-4784, ext. 310.
