Gentlemen,

RTM Savannah, Inc., a Georgia corporation, has been transacting business in Florida since June 1, 1997. On April 28, 1997, we qualified its parent company RTMSC, Inc. to transact business in Florida, and have been dutifully filing all necessary documents to keep this qualification in good standing. However, as we were in the process of preparing our and State tax returns for RTM Savannah, Inc., we realized that even though the parent company was qualified to transact business in Florida, RTM Savannah, Inc. (RTMSC, Inc.'s subsidiary) was in fact the company that was transacting business in Florida. We will be filing the initial Florida state tax return for RTM Savannah, Inc. prior to March 1, 1999.

In an attempt to correct our unintentional mistake, we are filing the following items to qualify RTM Savannah to transact business in Florida:

- Application by Foreign Corporation for Authorization to Transact Business in Florida
- Certificate of Existence State of Georgia
- Check in the amount of \$370.00 to cover
 - \$70.00 filing fee
 - \$150.00 annual filing fee for 1998
 - \$150.00 annual filing fee for 1999
