We have received your document for FAMILY ALTAR OF THE AIR, INCORPORATED and your check(s) totaling \$87.50. However, the document has not been filed and is being retained in this office for the following:

Pursuant to section 607.1502(4), 617.1502(4) or 608.502(4), Florida Statutes, this office collects a civil penalty of \$1000 for each year this entity transacted business or conducted its affairs in Florida prior to qualification and the appropriate annual report fees that would have been due this office had the entity qualified the year it began operations in this state. The amount due this office to cover both annual report and penalty fees is \$1061.25.

Dear Jennifer,

I am writing on behalf of letter number 299A00006992 wherein we have been assessed a \$1000 penalty for conducting business prior to obtaining qualification to do so and failure to submit the appropriate reports in 1998.

As director of Family Ministries I would like to extend my personal apology for the deficiency on my part. I was not aware of the necessity of obtaining the "certificate of authority" from the Department of State and take responsibility for the oversight. Although ignorance is not an adequate explanation, I am appealing to those who may have authority over this matter to grant us leniency and to remove or reduce the amount of the fine.

Family Ministries is a benevolence organization which assists local churches and civic organizations by providing temporary financial assistance to families in crisis. Since we began operation in May of 1998 we have helped approximately 125 families in matters ranging from paying light bills to providing formula for their babies. We have a fully stocked food pantry which distributes food on a daily basis to hundreds of individuals not considered in the aforementioned number.

Family Ministries is entirely funded through private contributions and none of its officers or directors (myself included) receive any compensation for our services it is, with the exception of one part time secretary, entirely volunteer. To take \$1000 from our modest budget would represent a significant hardship on our organization and would have to be taken from the benevolence fund. In other words, approximately five legitimately needy families would not receive assistance.

I humbly ask that you reconsider this fine and waive the full amount of the fine or reduce it in some manner. I would also like to point out that Family Ministries did not commence operations until May of 1998 and therefore was only conducting operations for eight months of the calendar year. I appreciate your consideration.

Based on my review of the file and the payments received from this non-profit corporation, it is my recommendation that this file be closed. Non-profit corporation has paid outstanding report fees from 1998 of \$61.25 and foreign non-qualified penalties are not collectable due to minimal cash flow for this entity, which wishes to be qualified to conduct its affairs in the State of Florida. Accordingly, it is recommended this non-profit corporation be issued a certificate of authority.



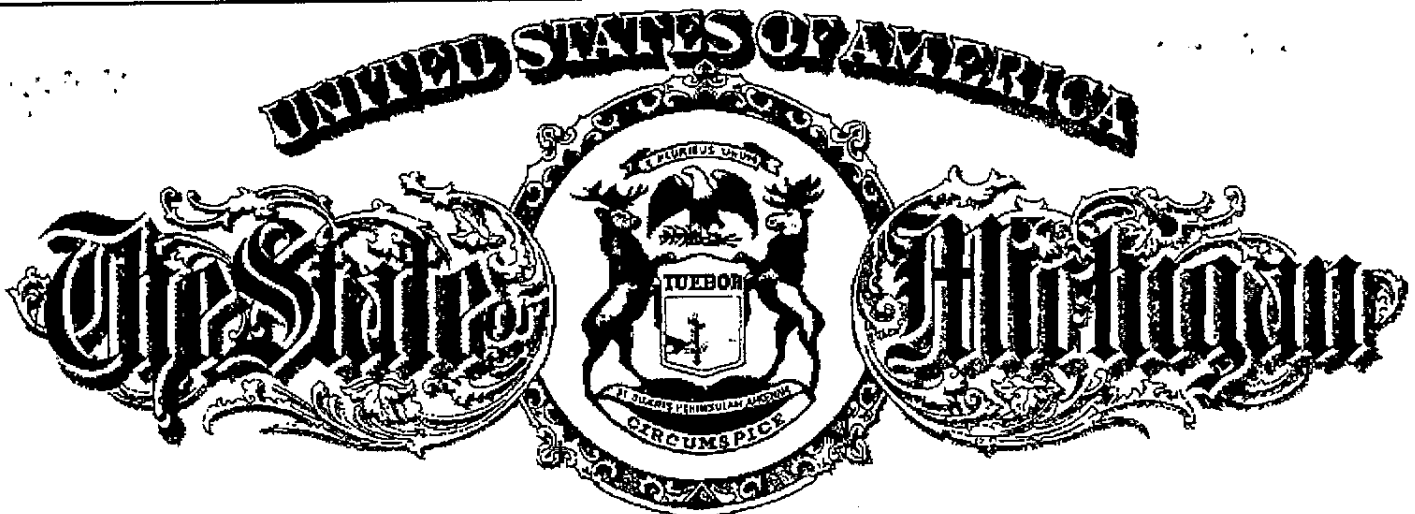

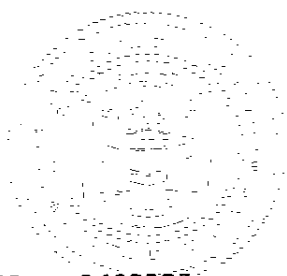
